OCRIMS COMMUNITY OUTREACH--CALIFORNIA COASTAL CLEANUP ON SATURDAY, SEPTEMBER 15

OCRIMS is looking for volunteers to participate in California Coastal Cleanup Day on

September 15th. This activity has grown in scope and magnitude over the years, and it is expected that more than 60,000 volunteers will lend a hand this year in picking up hundreds of thousands of pounds of trash and recyclables from beaches, lakes, and waterways.

First and most importantly, everyone can participate in Coastal Cleanup Day, no matter what age. The actual Cleanup effort starts at 9:00 a.m. Each Cleanup site will be headed up by one or more Site Captains who will be in charge. Once you arrive, seek out your Site Captain and follow his/her instructions.

All the supplies you need will be provided: trash and recycling bags, gloves, etc. Each volunteer will need to bring or sign a liability waiver before they can start the Cleanup. You can save yourself some check-in time if you bring a signed waiver downloaded from:

TOP 10 CAUSES OF WORKPLACE INJURIES

The U.S. workplace is getting safer, but the cost of the most serious workplace injuries is rising, according to the findings of the 2018 Workplace Safety Index.

The number of the most serious workplace injuries and illnesses fell by 1.5 percent, while their cost – medical and lost-wage payments – increased by 2.9 percent between the 2017 and 2018 reports. The rank order of the top ten causes remained the same.

The total cost of the most disabling work-related injuries, causing employees to miss six or more days of work, was \$58.5 billion, with the 10 leading causes accounting for \$51.4 billion of that total, according to the index. The top ten causes and their costs are shown in the graph.

Top 10 Causes and Direct Costs of the Most Disabling U.S. Workplace Injuries^{1,2}



The annual ranking helps employers, risk managers, and safety professionals improve workplace safety by highlighting its financial impact and focusing resources on the leading causes of serious work-related injuries and illnesses. While overexertion continues to be the leading cause of serious workplace injuries, Falls account for a growing proportion of losses.

To effectively improve safety, employers should understand the root causes of the most

serious workplace injuries they experience, and the ways to effectively mitigate these through training, equipment and work design. Third-party administrators, brokers, and agents can be a key resource to employers in these efforts.

Study Methodology:

The annual Workplace Safety Index is based on information from Liberty Mutual, the U.S. Bureau of Labor Statistics (BLS), and the National Academy of Social Insurance. Liberty Mutual and BLS injury data are analyzed to determine which events caused employees to miss six or more days of work. The Index then ranks those events by total workers compensation costs, which include medical and lost-wage payments.

To capture accurate injury cost data, each Index is based on data three years prior. Accordingly, the 2018 Index reflects 2015 data.

LITTLE LEAGUE® WORLD SERIES FACTS

The Little League® Baseball World Series has become almost as popular as the Major League Baseball World Series. This year, the event takes place from August 16-26. Here are some facts about Little League®.

- ↓ Little League[®] was founded in 1939 by Carl E. Stotz.
- The organization is headquartered in South Williamsport, Pennsylvania, on the 72-acre Little League International Complex, with five regional offices in the U.S. and four internationally.
- Approximately 2.4 million boys and girls play Little League, worldwide.



- Little League is played in more than 80 countries and in all 50 states.
- The first leagues outside the United States were formed in 1950 on either side of the Panama Canal, the Pacific and Atlantic Little Leagues of Balboa.
- ↓ The first Little League Baseball[®] World Series night game was Aug. 24, 1992.
- Little League organizes seven World Series. The oldest is the Little League Baseball World Series, held in Williamsport, which was first played in 1947. The newest is the Little League Intermediate (50/70) Baseball Division, held in Livermore, Calif., which was first played in 2013.
- Current Little League President and CEO Stephen D. Keener is the first leader of the organization to play Little League. He is also the father of two Little League graduates, and his father worked at Little League Baseball Camp.
- ↓ In 1953, Joey Jay became the first Little League graduate to play Major League Baseball.
- More than 50 confirmed Little League Baseball World Series graduates have gone on to play Major League Baseball. Boog Powell (1954 LLBWS) is the first to play in the MLB World Series in 1966.
- In 2015, Lloyd McClendon (1971 LLBWS) and Kevin Cash (1989 LLBWS) became the first two LLBWS graduates to manage against each other in an MLB game.
- In 1948, U.S. Rubber, the maker of Keds, became Little League's first national sponsor. That sponsorship led to the development of rubber-molded cleats, now used worldwide for many outdoor sports.
- Mo'ne Davis became the first female Little League Baseball World Series participant to win a game as a pitcher in 2014.
- In 2015, the Little League Baseball World Series Total Attendance record was broken with 469,964 fans.
- **4** There are 56 members of the Little League Hall of Excellence.
- There are 23 confirmed members of the National Baseball Hall of Fame who have played Little League baseball.
