Fun Facts

- Québec City, founded in 1608, was named after the Amerindian word Kébec, which means "where the river narrows" in the Huron language.
- The famous battle of the Plains of Abraham in 1759, with opposing generals Montcalm and Wolfe, took place just a short walk from the Convention Hall. Nowadays, the Plains of Abraham welcome thousands of people for concerts by international artists, such as Paul McCartney and Céline Dion every summer.
- Québec City's Musée de la Civilisation is now presenting the Egyptian Magic exhibition, which brings together prestigious artifacts coming from some of the most famous Egyptian collections, in collaboration with the British Museum in London and the Louvre Museum in Paris.
- Without a NHL hockey team since the departure of the Nordiques in 1995, Québec City inaugurated its new arena on September 11. Hosting shows and events, the arena is also an attempt to attract a new professional hockey team to the city.
- Reminiscent of European cities, Old Québec was designated as a "World Heritage Site" by UNESCO in 1985.



More Fun Facts

- This fall, a group of developers unveiled a project for the construction of a 250-metre tower at the entrance of Québec City. Once completed, it will be Canada's highest tower east of Toronto.
- A few miles from Québec City are the impressive Montmorency Falls. At a height of 83 meters, they are 30 meters higher than Niagara Falls.
- The Château Frontenac was built at the end of the 19th century by the Canadian Pacific railway company as a luxury stopover hotel. It has since been the scene of several historical events. including the Québec War Conferences of 1943 and 1944 with Franklin D. Roosevelt, Winston Churchill and Mackenzie King in attendance. The Château Frontenac is the world's most photographed hotel.
- Petit-Champlain Street, located in Old Québec, was declared "most beautiful street of the country" in Canada in 2014. It contains shops, restaurants, the famous Breakneck Stairway and a theatre.
- Each year Québec City hosts the "Québec City Staircase Challenge", inviting competitors to climb the 19 kilometers of stairs linking the lower town with the upper town. It is the only event of its kind in the world are you game?
